The view of Mundon Parish Council is that too much money is wasted on poorly planned/executed Highways projects, especially those involving works around bridges, such as Mundon Wash, Hoe Mill, Finchingfield, Army & Navy and others.

It would appear budgets and timescales are often disregarded, with no apparent recourse to any party.

Impacts of extended works have huge implications on local people and businesses, yet there appears to be a lack of specific local consideration, as there is rarely communications with either the Parish Council and/or local businesses.

We would encourage all Highways projects to make contact with the relevant Parish Council, which can often provide relevant local knowledge to help alleviate negative impacts of works.
