Background

In 2022, Essex County Council (ECC) launched a pilot requiring users to book visits to recycling centres. It was introduced in response to challenges of high demand at peak times, particularly at weekends, leading to queuing and congestion, impacting neighbouring properties and the environment, as well as reducing operational efficiency and causing longer waiting times.

The purpose of the pilot was to test if introducing a booking system to manage demand across the available opening hours would:

- improve operational efficiency
- reduce congestion at recycling centres
- help manage waiting times by smoothing demand across the available opening hours
- improve the customer experience
- reduce misuse by commercial vehicles
- encourage users to separate recyclable waste through a more positive on-site experience

A simple and accessible booking process is in place for all vehicles at all 21 recycling centres. Bookings can be made online via the Love Essex website <u>www.loveessex.org/bookings</u> or by telephone through the ECC Contact Centre, Monday to Friday, 8.30am to 5pm.

During the pilot, pedestrians, cyclists and Blue Badge holders have been exempt from booking. Residents from nearby areas in Suffolk and Hertfordshire can also use recycling centres due to reciprocal agreements.

Our proposal

ECC is proposing to keep a recycling centre booking process permanently.

Key points of the proposal are:

- bookings will be required at all sites and opening hours
- bookings will be required for cars and cars with a single axle trailer
- bookings will be required for visits to the nine van-friendly sites in a large vehicle
- Blue Badge holders, pedestrians and cyclists will not have to book
- bookings can be made online via the Love Essex website (<u>www.loveessex.org/bookings</u>) or by telephone through the ECC Contact Centre, Monday to Friday, 8.30am to 5pm.

Further information

Essex County Council (ECC) is the Waste Disposal Authority. ECC is responsible for disposing of waste collected by the district, city and borough councils, and providing Recycling Centres for Household Waste ("recycling centres") for residents. It operates 21 recycling centres (visit **loveessex.org/find-yournearest-recycling-centre** to view a full list).

The pilot had three phases:

- **phase 1:** From February 2022, large vehicles were required to book a visit to the nine large (van-friendly) sites
- phase 2: From June 2022, cars were required to book a visit to Rayleigh Recycling Centre
- **phase 3:** From March 2023, all vehicles were required to book visit to all recycling centres

About the booking system

- bookings can be made online at <u>www.loveessex.org/bookings</u> or by calling the Essex Contact Centre, Monday to Friday, 8.30am to 5pm
- booking slots are for a single 15-minute visit for cars, 20 minutes for large vehicles
- bookings can be made with as little as 15 minutes notice or up to six weeks in advance
- the number of bookable visits is set on a site-by-site basis
- residents can cancel bookings

Our proposal for cars

ECC is proposing to keep a booking process permanently for cars at all sites and for all opening hours.

Our evaluation of the pilot has shown the booking process has:

- improved the customer experience
- reduced congestion around sites
- helped manage waiting times by smoothing demand across the available opening hours

Creating a positive on-site experience may also encourage residents to separate recyclable waste.

ECC is proposing to keep a booking process for large vehicles at van-friendly sites and for all opening hours.

Vans and large trailers take up a lot of space at recycling centres and often take a long time to unload, leading to long queues and waiting times to access sites.

Our evaluation of the pilot has shown the booking process has:

- improved the customer experience
- reduced congestion around sites
- helped manage waiting times by smoothing demand across the available opening hours
