Sample overview

- 30 x participants, all to be living within Essex (excluding Southend and Thurrock)
- All to be 'digitally savvy'/comfortable with using technology
- To include a good geographic spread across Essex (e.g. Chelmsford, Colchester, Harlow, Basildon and surrounding areas), including some in more rural areas
- To include a balance of genders (this does not need to be 50/50 as we acknowledge women are more likely to participate in research)
- To include a distribution of age ranges
- Minimum 2 x from black or minority ethnic groups
- Minimum 2 x disability and / or with long-term limiting health condition







The charts below show the demographic make up of the 23 participants who attended the five focus groups.




To which gender identity do you most identify?






To which of these ethnic groups do you consider you belong?
